Suspected of causing cancer. This material contains petroleum asphalt. IARC has determined that there is inadequate evidence that undiluted, air-refined asphalt is carcinogenic to animals. There is only limited evidence that undiluted, steam-refined and cracking-residue asphalt are carcinogenic to animals. Additionally, IARC has concluded that there is inadequate evidence that asphalts alone are carcinogenic to humans.

Condensed asphalt fumes, which are generated under laboratory conditions and are chemically different from those found during typical asphalt operations, have been reported to cause bacterial mutations. However, inhalation of asphalt fumes by laboratory animals, during controlled studies, did not produce lung cancer. Additionally, human studies have not established a link between lung cancer and asphalt fume exposure to date. This product may contain trace amounts of polynuclear aromatic hydrocarbons (PAHs) as naturally occurring constituents of crude oils from which asphalt is derived.
